ALLIED PARTNERS TREATY

30th OCTOBER 2017

**BETWEEN THE INDEPENDENT
SOVEREIGN NATIONS OF**

MANNA WORLD HOLDING TRUST

AND

KINGDOM OF MANNA

On this the 30th day of October in the year 2017 a meeting took place between *The Kingdom of Manna represented by His Majesty Jesper Ellermann reigning Royal Monarch, and Manna World Holding Trust represented by Kimberly A. Goguen, Trustee* both being independent Sovereign Nations representing each of it's own interests have agreed to form an Alliance in matters of security with terms outlined as follows;

The Kingdom of Manna agrees to provide protection to The Sovereign of Manna World Holding Trust as long as this treaty remains in force. Kingdom of Manna shall provide protection and it's defense forces in all areas within it's power to include but not limited to, personal security, armed forces, cyber security, and political protection. Manna World Holding Trust agrees to provide The Kingdom of Manna with it's annual budget, development and infrastructure funding in exchange for these services to be submitted annually no later than the 31st of December. Further The Kingdom of Manna agrees to allow Manna World Holding Trust to utilize it's electronic monetary systems, embassy(s), personal protection units, diplomatic transportation, etc. in order to execute it's Redistribution of Wealth Program and Independent Sovereign World Program.

Secondly, Manna World Holding Trust in cooperation with the Kingdom of Manna have agreed to form this Allied Partners Treaty in order to build a Global Security System. Both Nations have reviewed the Global Security System Plan and agree in principle the following;

The Kingdom of Manna declares it's ability and willingness to build and develop the Global Security System Plan and Manna World Holding Trust declares it's willingness to provide all necessary funding on an ongoing basis in order to execute said plan.

This Allied Partners Treaty between the independent sovereign nations of The Kingdom of Manna and Manna World Holding Trust shall remain in affect for a period 1 year and shall automatically renew each year on the 30th of October into perpetuity or until both parties agree to terminate. Shall either party not fulfill it's Nations duties under the terms and conditions of this Treaty, a period of 6 months shall be provided to the offending Nation to rectify any deficiency shall the deficiency continue this Treaty shall terminated on the following 30th of October of the same year term.
