

To Whom It May Concern:

The following is a representation of events that has been brought to the attention of Representative Skillicorn of Kane County, IL, various related elected officials, and to the media by SPEAK Project, an independent action news organization affiliated with international humanitarian funding agent, Unknown Country (International Trust).

My name is Steffen Rowe and I represent the International Trust that has been the sole funding source for the Humanitarian Projects funded by the United Nations for the past 70 years. I am also the founder of the Speak Project, which we use to fill a void within the mainstream media by ensuring documented information is delivered accurately to the public. We are dedicated to speaking the truth as well as providing solutions and working with our members to take appropriate and lawful action that will make a difference. These efforts have forced us to create a Child Advocacy Division headed up by Human Rights Activist, Michaele Walker.

I am writing this letter to ask for your intervention, support, and assistance in a case of legalized child abduction that has occurred in Kane County, Elgin, Illinois.

Kara Witkowski is the mother of two children, James (2) and Sasha (4). The father of the children is Kara's ex-boyfriend, Thomas Biel.

Kara was raped and sodomized by her ex-boyfriend, Thomas Biel. Kara reported the incident to the Elgin Police Department and followed proper procedures to be examined after the rape occurred. The rape kit results are attached to this email proving that she was in fact a victim of this crime.

Further damning evidence against Thomas Biel was submitted to the Elgin Police Department by Witkowski in the form of Biel's hard drive, just days after the rape and sodomy incident. This hard drive included 44,000 pornographic files, with 47 pubescent girls identified by National Center for Missing and Exploited Children (NCMEC), 400 pictures of prepubescent girls who were recognized and positively identified, and almost 280 pictures of unidentified girls listed as new victims. However, the judge would not allow this information to be entered as evidence in the case, stating it was "hearsay."

On March 25, 2019, Kara Witkowski, filed for an Order of Protection against Thomas Biel, which included the protection of the two children, James and Sasha, which was granted on that date.

On April 11, 2019, during a court hearing on the Order of Protection, Thomas Biel admitted to the court and to the Guardian ad litem (GAL) that he was guilty of committing rape against Kara Witkowski. Judge John G. Dalton granted the order, acknowledging the need for protection of the mother and children from the father, an admitted rapist. Kara Witkowski was awarded full custody of her two children, James (1 ½) and Sasha (3 ½).

On May 15, 2019, Thomas Biel filed for an Emergency Motion to Restrict Parenting against Kara Witkowski. Kara was not present at this hearing because she was repeatedly told that she did not need to be there on that day. Kara's lawyer, Melissa Kuffel, stated that she objected to the hearing without Kara's presence there, but the judge went forward anyway.

During this hearing, the GAL claimed that Kara was suffering from post-traumatic stress disorder due to the rape and sodomy perpetuated on her by Thomas Biel. The Domestic Violence Specialist at the Elgin Police Department, on the other hand, made an opposite statement, declaring that the mother was doing everything right and was a perfect mother.

After the court heard the report of the GAL and reviewed the psychological evaluations of Kara, Judge John G. Dalton, overturned his own judgment and granted full custody of the children, James and Sasha, to the father, Thomas Biel. That same afternoon, while Kara was at work, the police went to her home to take the children and placed them in the custody of the father. Kara was ordered to have supervised visitations with her children for six hours each day on Mondays, Tuesdays, and Wednesdays.

During visitations with the two children, Kara began noticing bruises on the children's bodies. Sasha would tell her mom that her grandfather was hitting her and touching her bathing suit zones. Alarmed, Kara took her 3-year-old daughter to be examined for potential sexual abuse. The doctor expressed concern and reported his findings and a protective order was granted against the grandfather, with whom Sasha was still living.

On August 4, 2019, Thomas Biel alerted Kara Witkowski while she was at work that James Biel, age one and nine months old at the time, was being treated at Alexian Brothers in Hoffman Estates for a prolapsed rectum. The child underwent rectal reconstructive surgery to correct this injury, which is a common injury among trafficking victims under the age of four.

On October 31, 2019, then two year-old James Biel, was found dead in the grandfather's bed. Less than eight hours after his death, a press release was issued that stated the police had no reason to suspect foul play in the child's death. Prior to the death of James Biel, the mother had been threatened by the godfather of the children, who said that she had better stop her efforts to get her children back because she was putting the life of her son James at risk by doing so. These threats were recorded and will be entered into the court of record this week, as well as all of the documented evidence pertaining to this case.

The daughter, Sasha, is still allegedly in their custody. We believe that this is a gross miscarriage of justice and an abuse of power by Judge Dalton. Furthermore, we have evidence to support that the Judge as well as Thomas Biel are complicit in a child sex trafficking ring that is operating through DCFS, in coordination with the justice system in Kane County.

Judge John G. Dalton owns a trucking company and a pizza restaurant. He brings foreign exchange students (minors) to his home for three weeks at a time approximately ten times a year. His partner is the Chief of Staff for Senator Christina Castro. The GAL, Julie Pirtle, admitted to being bribed to lie about Kara Witkowski being an unfit mother whom she feared would kill the children. The bribe came from the godfather of the children, Lawrence Thomas Riordan, who is the same man who violently threatened Kara to stop fighting for her children because she was putting her son James' life at risk. The threat was recorded and an affidavit of events is being notarized.

We have begun to garner public support on a national level and fully intend to publish this letter as well as any and all actions undertaken by the local government assisting our efforts to return custody of Sasha to her mother, or justify awarding custody to the known sexual abuser, in whose custody one child has already been found dead.

In addition, regardless of what happens with Sasha, we will be filing grievances for Breach of Trust, Gross Negligence, and Criminal Racketeering against the State of Illinois, Kane County, and Judge John G. Dalton. Once this matter is resolved we will also be filing a lawsuit under the RICO Act, which we have more than enough documentation to prove.

We operate with the full knowledge of the dangers of exposing such a criminal enterprise. We have already taken steps to ensure the safety of our people and the security of our documentation.

We would love to know that you are advocating for the children of Illinois and are in support of our efforts. We will publish this letter as well as additional evidence to support our claim on Wednesday, November 13, 2019 on SpeakProject.Net, as well as on nationally syndicated newspapers, social media platforms, and internet media outlets.

To be perfectly clear, I am not concerned about any of the politicians, law enforcement, or private citizens involved that may be angered by the Speak Project for making this case public. I am solely concerned for the health and well-being of the four year old, Sasha, her safe return to her mother, and that both of these Americans are given the chance to heal and recover.

I'm certain you have the ability to make phone calls on the behalf of this child and her mother. I cannot express the urgency of this matter enough as each day this child is in the custody of the abuser, is an increased opportunity for something tragic to occur. This mother has already experienced enough tragedy due to the incompetence of Judge John G. Dalton.
