THIS LETTER IS TO INFORM YOU THAT A GRAND JURY HAS BEEN FORMED TO DELIBERATE ON CONSTITUTIONAL VIOLATIONS THAT MAY HAVE AN IMPACT ON YOUR STATE. TO COMPLY WITH THE CONTRACTUAL OBLIGATIONS OF YOUR OATH OF OFFICE, IT IS NECESSARY FOR YOU TO MAKE THIS INFORMATION AVAILABLE TO ALL EMPLOYEES WITHIN THE SCHOOL DISTRICT'S THAT ARE UNDER YOUR ADMINISTRATION.

THE PRELIMINARY FINDINGS OF THE GRAND JURY HAVE IDENTIFIED THAT FALSE MANDATES REQUIRING VACCINATIONS FOR CHILDREN TO ATTEND SCHOOL, OR ADMINISTERED WITHOUT PARENTAL CONSENT ARE VIOLATIONS OF PEOPLE'S FUNDAMENTAL HUMAN RIGHTS AS STATED IN THE NUREMBERG CODE.

THESE ALLEGED MANDATES ARE REQUIRED BY THE WORLD HEALTH ORGANIZATION UNDER THE ORDER OF THE UNITED NATIONS WHICH HAS NO JURISDICTION ON AMERICAN SOIL. UNDER NO CIRCUMSTANCES ARE PARENTS OR CHILDREN TO BE DENIED THEIR UNALIENABLE RIGHTS FOR ANY REASON, AND CERTAINLY NOT AT THE HAND OF FOREIGN AGENTS ON AMERICAN SOIL WHO ARE THEREFORE CONTRACTUALLY BOUND BY THE CONSTITUTION.

ANY VIOLATION OF THESE LAWS BY ANY MEMBER EMPLOYED BY THE BOARD OF EDUCATION WILL RESULT IN BOTH CIVIL AND CRIMINAL ACTION AGAINST EACH INDIVIDUAL, AND ENTITY.

YOUR FAILURE TO DISSEMINATE THIS INFORMATION TO YOUR STAFF IN EVERY SCHOOL UNDER YOUR JURISDICTION WILL RESULT IN IMMEDIATE CIVIL AND CRIMINAL ACTION AGAINST YOU PERSONALLY.
